

BASCA INC. Chance Drawing Rules and Regulations

BASCA INC. Drawing Official Rules. This is a fundraising effort to benefit BASCA INC., an official 501c3 not for profit organization located at 352 Stowe Ave, Orange Park, FL 32073. 1. Tickets will be sold for a suggested donation of \$50.00 each. The odds of winning depend on how many tickets are issued, but will be no more than 750 donated entries. First prize is the car, second prize is a weekend getaway and third prize is a wheeled duffle bag. 3. Must be a legal U.S. resident 18 years or older at time of entry to claim prize if selected. Must meet additional eligibility requirements if selected as the winner of the car. Proof of identity will be required.
